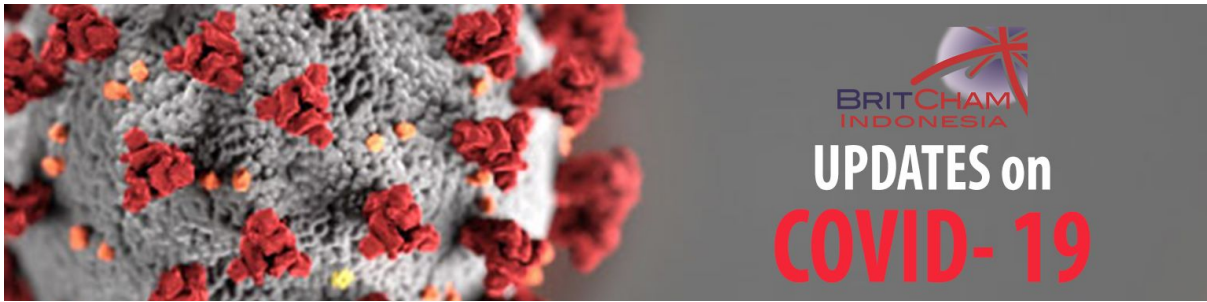

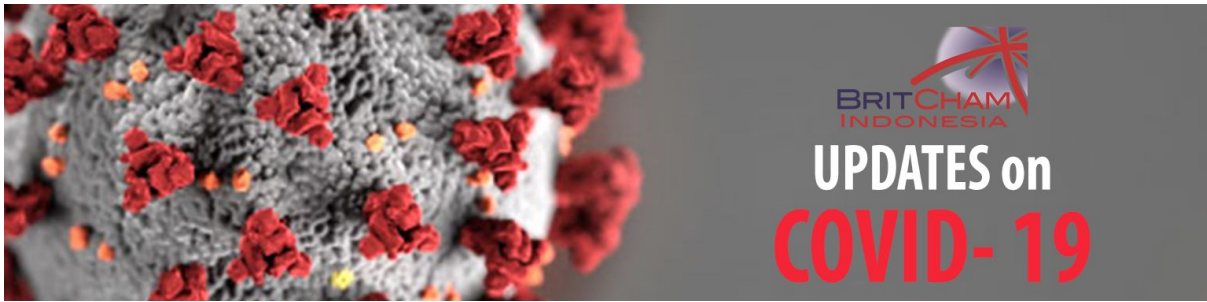

LSSR across Indonesia

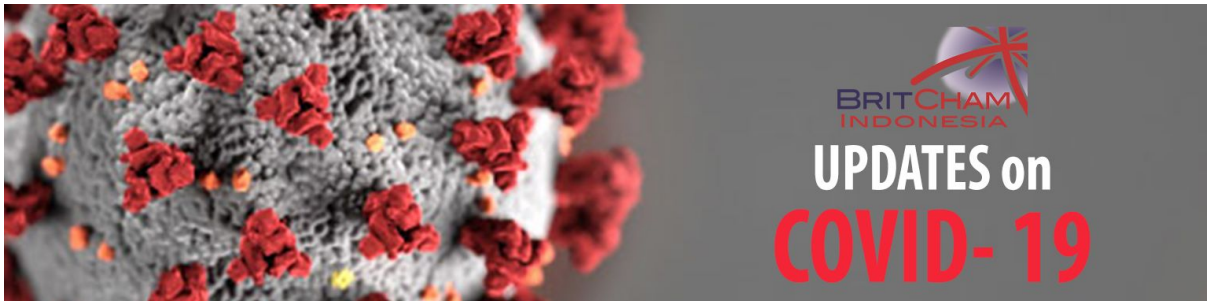
- **Tangerang, Banten Province** is extended to June 28, 2020. LSSR regulation: [Governor of Banten Decree no. 443/Kep.140-Huk/2020](#) [[SSEK translation](#)] and the Governor of Banten Regulation no. 16 (2020) [[SSEK translation](#)]
- **West Java** is extended through the West Java Governor Decree no.443/Kep.304-Hukham/2020 to July 2, 2020 for Bogor, Depok and Bekasi. LSSR in other regions is extended to June 26, 2020. LSSR regulation: [West Java Governor Regulation no. 36 \(2020\)](#) & Guidance to Prepare for the New Normal: [West Java Governor Regulation no. 46 \(2020\)](#).
- **West Sumatera** started implementing the New Normal on June 8, except for Padang city and Mentawai Regency that will go through a transition period until June 12, 2020 and June 20, 2020 respectively.
- **Palangkaraya, Central Kalimantan** replaced LSSR with Humanistic Village Social Restriction (*Pembatasan Sosial Kelurahan Humanis/PSKH*) since May 1, 2020.

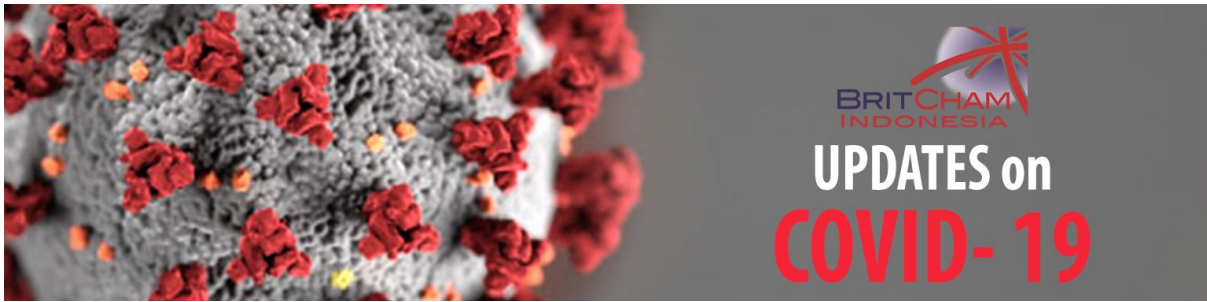


6. RI Immigration Policy_ updated on 11/06

The available services are 1) **Change of status of an Immigration Stay Permit Application**; 2) **New temporary stay permit (ITAS) issuance**; 3) **Immigration Certificate of Residency (SKIM) issuance**; 4) **Indonesian dual citizenship & immigration facility application**. 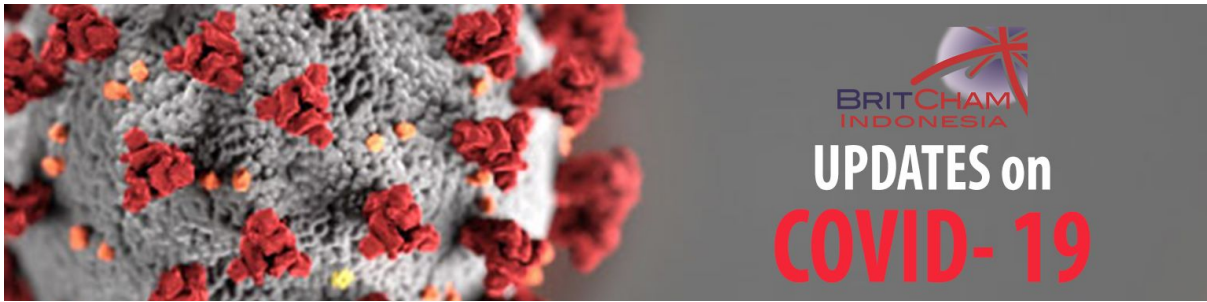

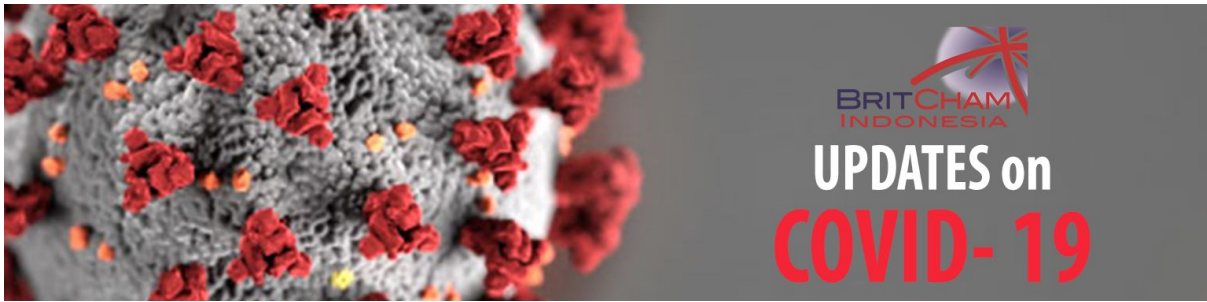

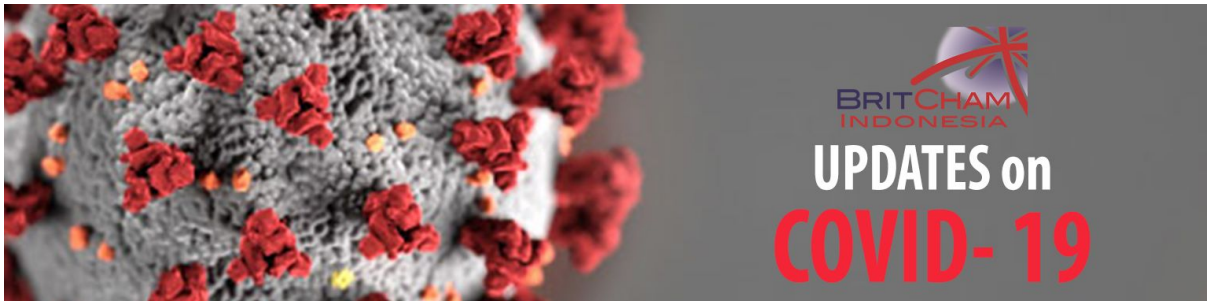

- BRITISH & other foreign nationals with work and residence permits are required to obtain a PCR test PRIOR to checking in for a flight returning you to Indonesia. The test certificate should be within 7 days of arrival. **If you already have a negative PCR test result, you will not have to take the Rapid/PCR test again. Otherwise, you must take rapid test upon arrival, 1) if the result is reactive you will be referred to the local emergency hospital/ referral hospital; 2) if the result is non-reactive, you must take the PCR test and be quarantined at your own expense until your PCR test result is issued.** This is for guidance and you should always check the latest government advice.
- As the British Embassy/Consulate in Indonesia do not have the capacity to receive your health clearance, please submit your health clearance to the medical team at the airport to be forwarded to the local Health Office for supervising your 14-days self-quarantine.

3. Job Retention Scheme *_updated on 11/06*

- The [Coronavirus Job Retention Scheme](#) will close to new entrants from 30 June. This means that the final date by which an employer needs to agree with their employee and ensure they place them on furlough is today, 10 June 2020. However, [people on paternity and maternity leave](#) who return to work in the coming months will be eligible for the scheme even after today.
