REGARDING**

**CRITERIA AND REQUIREMENTS FOR THE TRAVELING OF PEOPLE IN THE PERIOD OF ADAPTATION OF NEW NORMAL TOWARDS A PRODUCTIVE AND CORONA VIRUS DISEASE 2019 (COVID-19)-SAFE SOCIETY**

**A. Background**

1. whereas with the reopening of some sectors of the community's lives during the spread of the Corona Virus Disease 2019 (COVID-19), it will have implications on the increase in activities of the traveling of people in the period of adaptation of new normal.
2. whereas in the framework of preventing and breaking the chain of the spread of the Corona Virus Disease (COVID-19) that has the potential to occur due to the traveling of people, it is necessary to formulate a Circular Letter regarding the Criteria and Requirements for the Traveling of People in the Period of Adaptation of New Normal towards a Productive and Corona Virus Disease 2019 (COVID-19)-Safe Community.

**B. Objectives and Purpose**

These criteria and requirements for the traveling of people are prepared with the objective to become a guideline for the traveling of people in the period of adaptation of new normal towards a productive and Corona Virus Disease 2019 (COVID-19)-safe life. Further, these criteria and requirements are prepared with the purpose of:

1. Increasing the implementation of health protocols in new normal for the creation of a productive and COVID-19-safe life; and
2. Increasing the prevention of the spread of the Corona Virus Disease 2019 (COVID-19).

**C. Scope**

The scope of the criteria and requirements for the traveling of people are:

2. Definition

**D. Legal Bases**

1. Law Number 4 of 1984 regarding Outbreak of Communicable Disease;
2. Law Number 24 of 2007 regarding Disaster Management;
3. Law Number 6 of 2018 regarding Health Quarantine;
4. Government Regulation Number 21 of 2008 regarding the Implementation of Disaster Management;
5. Government Regulation Number 21 of 2020 regarding Large-Scale Social Restrictions to Accelerate the Handling of the Corona Virus Disease 2019 (COVID- 19);
6. Presidential Decree Number 7 of 2020 regarding Task Force for the Acceleration of Handling COVID-19 as lastly amended by Presidential Decree Number 9 of 2020 regarding the Amendment of the Presidential Decree Number 7 of 2020 regarding Task Force for the Acceleration of Handling COVID-19;
7. Presidential Decree Number 11 of 2020 regarding Stipulation of the Corona Virus Disease 2019 (COVID-19) as a Public Health Emergency;
8. Presidential Decree Number 12 of 2020 regarding the Stipulation of Non-Natural Disaster of the Corona Virus Disease 2019 (COVID-19) as a National Disaster;

#### **E. Definition**

The traveling of people as referred to in this Circular Letter is the movement of people from one region to another region based on provincial/district/city administrative boundaries, and the arrival of people from abroad entering the territory of the Unitary State of the Republic of Indonesia by using private vehicles or public land, railways, sea, and air transportation.

#### **F. Criteria and Requirements**

1. Every individual who carries out the traveling of people is obligated to implement and adhere to health protocols namely wearing masks, maintaining distance, and washing hands as criteria of the traveling of people.
2. The requirements for domestic traveling of people:
  - a. Every individual who carries out the traveling of people with a personal vehicle is responsible for their own health, and is subject to and complies with the applicable terms and conditions;
  - b. Every individual who carries out the traveling of people by public land, railways, sea, and air transportation must meet the following requirements:
    - 1) Present a personal identification (*Kartu Tanda Penduduk*/KTP or other valid identification document);
    - 2) Present a statement letter of PCR test with negative result which is valid for 7 days or a statement letter of Rapid-Test with a non-reactive result which is valid for 3 days at the time of departure;

- 3) Present a statement letter of the absence of symptoms of influenza-like illness issued by a Hospital / Community Health Center (*Puskesmas*) Doctor for regions that do not have PCR Test and / or Rapid-Test facilities;
  - c. The requirements for domestic traveling of people are exempted for the traveling of commuters and the traveling of people within an agglomeration territory / region.
  - d. Download and activate Peduli Lindungi application on their mobile device.

3. The requirements for the traveling of people arriving from abroad:
- a. Every individual who comes from abroad must obey and comply with the applicable terms and conditions:
    - 1) every individual who arrives from abroad must undergo a PCR Test upon arrival, if that person has not undergone one and is unable to present a PCR Test result letter from the country of departure;
    - 2) the requirement for PCR Test examination for the traveling of people arriving from abroad is excluded for Cross-Border Post (*Pos Lintas Batas Negara/PLBN*) that do not have any PCR equipment, by conducting a rapid test and presenting a statement letter of the absence of symptoms of influenza-like illness and are exempted for the traveling of commuters who go through PLBN by presenting a statement letter of the absence of symptoms of influenza-like illness issued by a Hospital Doctor / Health authority.
  - b. during the PCR Test results waiting period, every person must undergo quarantine at a special quarantine accommodation location provided by the government; or
  - c. utilizing quarantine accommodation (Hotel / Lodging) that has received certification of COVID-19 quarantine accommodation from the Ministry of Health;
  - d. download and activate Lindungi Peduli application on their mobile device.

## **G. Monitoring, Control and Evaluation**

1. The government, regional government, public transportation provider authority assisted by elements of the Indonesian National Army (TNI) and Indonesian National Police (Polri) shall jointly organize the control of the traveling of people and public transportation that are COVID-19 safe;
2. the authority, organizer and provider of public transportation shall assign supervisors during the operation of public transportation;

3. The government and regional governments have the right to stop and / or prohibit the traveling of people based on this Circular Letter and / or provisions of the laws and regulations;
4. for individuals who are declared to have symptoms of influenza-like illness or who are declared reactive / positive for COVID-19 to be quarantined at a place determined by the government or to conduct an independent quarantine under the government supervision;
5. authorized institutions (Ministries / Institutions, TNI, Polri, and regional governments) shall discipline the COVID-19 health protocol and law enforcement according to the provisions of the applicable laws and regulations.

#### H. Closing

With the enactment of this Circular Letter:

1. Circular Letter Number 4 of 2020 regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Handling of The Corona Virus Disease 2019 (COVID-19); and
2. Circular Letter Number 5 of 2020 regarding Amendment of Circular Letter Number 4 of 2020 Regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Handling of the Corona Virus Disease 2019 (COVID-19);

are revoked and declared invalid.

This Circular Letter is effective as of the date of its stipulation, and can be amended in accordance with the development of the situation, and shall end upon the stipulation of a Presidential Decree terminating Presidential Decree Number 11 of 2020 regarding Stipulation of the Corona Virus Disease 2019 (COVID-19) as a Public Health Emergency.

In witness thereof, this Circular Letter shall be observed and implemented in a responsible manner.
