THE AREA OF THE PROVINCE OF THE SPECIAL CAPITAL
REGION OF JAKARTA AS MEASURES TO PRECIPITATE
MITIGATION OF THE CORONA VIRUS DISEASE 2019 (COVID-
19)

WITH THE BLESSINGS OF GOD ALMIGHTY

THE MINISTER OF HEALTH OF THE REPUBLIC OF INDONESIA,

Considering

:

- a. that existing data shows a significant and rapid increase in the spread of the Corona Virus Disease 2019 (COVID-19) followed by incidents of local transmission in the Capital Region of Jakarta;
- b. that based on epidemiological studies and considerations on social, economic, and other aspects.it is deemed necessary to implement a Large-Scale Social Distancing status in the Capital

Region of Jakarta in order to suppress further spread of the COVID-19;

- c. that based on considerations as referred to above in point b, it is deemed necessary to establish a Decree of the Minister of Health on Large-Scale Social Distancing in the Capital Region of Jakarta In Order to Precipitate Mitigation of the Corona Virus Disease 2019 (COVID-19);

DECIDES:

To Stipulate DECREE OF THE MINISTER OF HEALTH ON ESTABLISHMENT OF LARGE-SCALE SOCIAL DISTANCING IN THE SPECIAL CAPITAL REGION OF JAKARTA IN ORDER TO PRECIPITATE MITIGATION OF THE CORONA VIRUS DISEASE 2019 (COVID-19).

FIRST To Establish Large-Scale Social Distancing in the Region of the Special Capital Region of Jakarta In Order to Precipitate Mitigation of the Corona Virus Disease 2019 (COVID-19).

SECOND The Regional Government of the Province of the Special Capital Region of Jakarta is obligated to implement Large-Scale Social Distancing as referred to in the FIRST Dictum in accordance with the provisions of the laws and regulation and consistently encourage and disseminate a clean and healthy lifestyle to the public.

THIRD The Large-Scale Social Distancing as referred to in the SECOND Dictum shall be implemented during the longest incubation period and may be extended in the event of evidence that the spread of infections is still

taking place.

FOURTH

This Decree of the Minister of Health shall take effect on the date it is stipulated.
