Patricia has extensive corporate governance experience. She is the Board Chair of Calgary Co-op, a large retailer (revenue ~\$1.25B annually) of grocery, petroleum, liquor, pharmacy, cannabis, and natural foods, leading the Board through strategic decisions such as a change of wholesale supplier, entry into retail cannabis, the acquisition of natural foods and pharmacy businesses, and over \$1B (with development partners) of capital redevelopment projects.

Patricia is also the Board Chair of the Real Estate Council of Alberta, the independent regulator that sets and enforces standards for commercial and residential real estate agents, mortgage brokers and property managers.

Other highlights of Patricia's board work include the oversight of delivery of Calgary's Green Line light rail infrastructure megaproject as well as the consolidation of four crown agencies into a single Alberta Innovates agency. She also served on the Board of First Air during its merger and integration with Canadian North, both 100% Inuitowned airlines. Patricia has also been the Board Chair of the YWCA of Calgary, the Calgary Film Centre and cSPACE Projects, all having significant real estate and capital projects during her board terms.

Patricia is a former General Counsel, Vice President, and Privacy and Compliance Officer. She held senior leadership roles with energy utilities and electricity retailers, property development, mortgage brokerage, insurance, and financial services companies.
