The following are extracted from relevant MACEOS Constitution and have been edited for your ease of reference.

## **CLAUSE 8: COMMITTEE**

- 8(3) All elected office bearers, except the President and Treasurer, will serve a two (2) year term and be eligible for re-election each term.
- 8(4) The President may serve not more than three (3) consecutive terms only and be eligible for re-election after a lapse of one (1) term.
- 8(5) The Treasurer may serve two (2) consecutive terms only and be eligible for reelection after a lapse of one (1) term.
- 8(8) Each Ordinary Member shall have one (1) vote for each post for the election of the officers.
- 8(10) Nominees for the election must have served at least one (1) term (2 years) as an Ordinary Committee Member before being eligible to be elected into the post of President, Vice-President, Secretary or Treasurer.
