



INDEMNIFICATION AND HOLD HARMLESS AGREEMENT

I / we the parent(s) or legal guardian(s) of _____, or the individual attending camp himself or herself, give our consent and approval for their participation in any and all activities of the AMERICAN UKRAINIAN YOUTH ASSOCIATION (AUYA) during the summer camp season. In consideration of my / our child's participation in said activities, I / we, the undersigned, agree to defend, indemnify and hold harmless AUYA, its directors, officers, managers, employees, coaches and agents, against any claim for damages, compensation or otherwise including all losses and expenses (including any legal costs or attorneys' fees) to the extent caused by me or our child while participating in any summer camp activities of AUYA, to the fullest extent allowed under Wisconsin Law. I / We recognize and acknowledge that there are certain risks of physical injury and I / we agree to assume the full risk of any such injury.

PARENTAL / ATTENDEE AGREEMENT

- 1. Any expenses related to medicines, doctors, and hospital treatments are solely my responsibility – whether I pay such expenses directly or make arrangements for payment of such expenses by a health insurer or other third party.
- 2. I understand that inappropriate behavior while under the camp administration's charge may lead to expulsion, and that in the event of expulsion **camp fees will NOT be refunded**.
- 3. I agree to make full payment to AUYA for registration for AUYA camp programming.
- 4. In the event of material damage to camp property caused by me or my child, I agree to pay for the repair of such damage.
- 5. I understand that each attendee of the AUYA youth camp must have the **complete** AUYA uniform: shirt, tie, belt, skirt / pants, socks, and dark shoes. NOTE: sneakers, athletic shoes, or sandals are NOT to be worn with the AUYA uniform. There will be an inspection of uniforms prior to the official opening ceremony.
- 6. I understand and acknowledge that some camp activities may take place outside of the AUYA campgrounds in Baraboo, Wisconsin, and I give my consent for me or my child to be transported to and participate in such activities.
