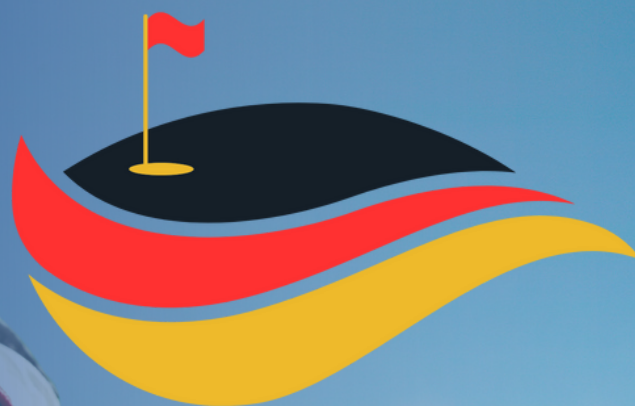


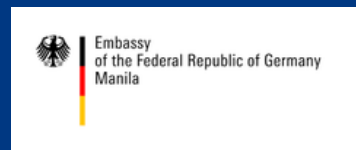


After the golf round, all participants will join the reception for players and distinguished guests. Awarding of tournament prizes will then follow.

Sponsorship Provisions:

Both contracting parties mutually commit to each other to meet the agreed time schedule, as well as to ensure the continuity and validity of the Agreement. Both parties shall inform each other about impending delays in written form and in time.

If during the project, additional work requirements or changes in the agreed scope of the project, the schedule or the project conditions, which require more time, ensues - then the involved parties must have a mutual agreement and/or coordination regarding any revisions. Changes must be specified and the resulting extra effort with corresponding additional remuneration must be regulated in written form.

Supplemental agreements may be applied upon agreement and confirmation with GPCCI. Subsequent supplemental agreements require the written form. Likewise, any changes and additions must be recorded in a written form. If the requirement about the written form should be cancelled, this must be made also in a written form (double requirement of the written form). The Agreement between GPCCI and the sponsor is valid upon written confirmation of the proposal through signing of a sponsor's indicated representative.

Unless otherwise stipulated, GPCCI reserves the ownership and use rights to documents pertaining to the event specified, which have been left to the client in relation to the contract. These documents are not available for transfer to third parties, unless GPCCI grants the sponsor, an expressed agreement in writing.

Sponsorship cancellation policy:

Cancellation notices must be submitted in writing. Cancellations made after 30th September 2022 will be subject to 50% of regular rate as administrative fee. Cancellation made after 10th October 2022 will be subject to 100% of regular rate as administrative fee.
