The National Economic and Development Authority (NEDA) has released the Philippine Development Plan (PDP) 2023-2028, a plan framed by the Marcos Jr. administration's 8-point socio economic agenda, which sets targets on economic growth, unemployment and poverty reduction as the government aims to bring back the country's economy.

Additionally, the government's economic team held the Philippine Economic Briefing last 23 January 2023 in Frankfurt, Germany to showcase investment opportunities in the country.

To further understand areas of cooperation between the Philippines and Germany, the German-Philippine Chamber of Commerce and Industry (GPCCI) will be organizing a luncheon forum on 12 April 2023 with NEDA Secretary Arsenio Balisacan.
