Delia North stepped down as the head of the Education Committee in 2023 due to commitments in the organization of the SASA 2023 conference. Lizelle Fletcher took over the role for 2023.

A request was made to assist with the Curricula Collation of all information on all undergraduate and postgraduate degrees related to Statistics in South Africa. The intention behind this project is to understand what is being taught in our degrees to aid with re-curriculation and benchmarking in order to facilitate movement of students between institutions. This initiative will be regularly updated.



There is some delay due to a request for an ethics approval. This application is being progressed.

Call for departments to advocate for student participation in the translation of **High School Statistics Videos**. The aim is for the videos to be available in all official languages.

6.2. Young Statisticians Network

Jocelyn Mazarura will be unavailable to continue as the Young Statisticians Coordinator due to work commitments. The EC will co-opt a SASA member for 2024.

6.3. ICCSSA Board

Prof Inger Fabris-Rotelli was elected as chairperson for the ICCSSA Board. ICSSA signed an MoU with SACNASP to move all members over to SACNASP without the application fee. ICCSSA is prohibited from providing professional designations from 2023. The decision on the proposed incorporation of ICCSSA into SASA will be discussed at the ICCSSA AGA in early 2024.

In the instance of ICCSSA being absorbed into SASA, their proposed role will be to facilitate closer collaboration between SASA and industry. As well as to help facilitate SACNASP registrations.

10.1. SACNASP

SACNASP representative Lientjie Mogano presented an overview of SACNASP the registration process. Mentorship programs with funding for activities are available through SACNASP, however both participants should be members. For members with a BCom background, the percentage of statistics and mathematics background will determine if registration with SACNASP is required, More information is available on the SACNASP website: https://www.sacnasp.org.za/.

10.2. National Strategy for Mathematical Sciences

The aim of this strategy is to increase the quality of mathematical sciences at schools and higher education levels. Several plans on how to proceed are discussed and will be taken forward in 2024. SASA is a stakeholder in this community. An open invitation was made to all SASA members to join this initiative.

10.3. New EC position: Funding Member

Current SASA EC structure requires the Sponsorship portfolio to build and maintain sponsorships and industry funding relationships. The EC would like to initiate a 7th EC position that will focus only on Funding (e.g. NiTheCS funding for the conference). Members agreed to the opting of the position in 2024.

<u>Lizanne Raubenheimer</u> volunteered to be co-opted position in 2024.

This position will be included into the review of the Constitution in 2025.

10.4. Working groups



The working groups will aim to create communities of research groups to help support each other. As the SIGs grow into these working groups, more formalized structure can be put into place which includes meeting at SASA etc. This will require that more SIGs be formed for example SIGs for Forecasting, Education Interest Group, Official Statistics, StatSNetSA, Statistics in Sport, Econometrics, Theoretical Statistics. A call will be sent out in 2024 to initiate these SIGs.

ANNUAL REPORTS

ANNUAL REPORT OF THE EXECUTIVE COMMITTEE 2023/2024

The SASA executive has been working hard in 2024. The two Education Committee projects are progressing well and will be completed in 2025. The first collection of the curriculums from all the Statistics Academic departments has been progressing under the leadership of Prof Michael von Maltitz from UFS. This coalition will go a long way to produce a resource for all universities on the curriculums taught in South Africa. Once completed the resource will be updated regularly and will provide information for every institution to re-curriculate with, when needed, and to obtain consistency across South Africa. This is particularly useful to allow for the mobility of students between institutions. The second project has been provided generous funding from NITheCS. The EC is planning the production of videos of the Grade 10 – 11 Statistics syllabus in all our official languages. The slides in English have been prepared during 2024. Early 2025 a call will go out to invite postgraduates to volunteer to translate the videos into all our languages and do a recording of the videos in that language. Each language team will be awarded a monetary amount for this contribution. We are very excited about this and the potential it will have in our school system for both learners and teachers. In 2024, I was involved in a small IEB workshop for teaching Statistics and they are very excited about these videos and the potential for also helping the teachers.

The National Strategy for Mathematical Sciences has progressed in 2024 with the formation of a committee and a strong collaboration with SAMF. The idea of an Institute for Mathematical Sciences and its Applications has been proposed by NGA-MaSS with COE-MaSS and SAMF. This aims to take forward the COE-MaSS after the funding is no longer provided to ensure the communities of Mathematics and Statistics in South Africa are further supported. If any SASA member would like to be involved in these initiatives they are welcome to contact the EC.

NITheCS has been very responsive to SASA in 2023 and 2024, providing funding for both the school video project as well as the SASA Conference. The institute was officially made permanent in 2024 and funding calls were made in mid-2024. StatSNetSA has applied to be funded through NiTheCS - more detail in that report.



SAS has once again been a loyal supporter of SASA and we thank them for all the assistance and collaboration.

The SASA Departmental Reps have been assisting the HODs of each department with communication and other SASA matters. Ensure you know who this is at your institution and inform the Secretary if communications are not received.

The South African Journal of Science invited SASA this year to write a paper that appears in their anniversary edition. Thank you to all the contributing authors. Our paper was the longest!

In June 2024 we held an HOD meeting with all the departments across the country. This was a successful first discussion and it was agreed the mid-year meeting and the meeting at the conference should be held every year.

In 2025 the EC will have several new committee members, including the incoming president Prof Daniel Maposa. I wish Daniel all the best with his term. Thank you to the current EC and their tireless commitment to SASA. SASA wouldn't function without such wonderful individuals.

ANNUAL REPORT OF THE EDUCATION COMMITTEE

Members

After ten years of dedicated service on the education committee, with six years as its chair, Lizelle Fletcher has stepped down. We extend our deepest heartfelt appreciation to Lizelle for her unwavering commitment and hard work in guiding the committee's initiatives and growth.

We also bid farewell to Sisa Pazi, who played a crucial role in organizing the Third-year and Honours bursary competitions during his tenure. We thank him sincerely for his contributions and dedication.

This year, we were pleased to welcome Amy Langston from Rhodes University to the committee. Amy joins a team of committed members, including Delia North, Yoko Chhana, Nombuso Zondo, and Michael von Maltitz, who continue to support the committee's mission.

Competitions

The Education Committee hosts four annual competitions, and beginning in 2023, all applications transitioned to an online format. Applicants now upload their documents via a link specific to each competition. Eligibility for any of these competitions requires SASA membership. In addition to the four annual competitions, this year, the committee announced a Statistics Poster Competition for university students, as part of the 2024/2025 International Statistics Literacy Project (ISLP).

Postgraduate Paper Competition

This year, there is a prize for the best published paper from a Masters or PhD student, as well as a prize for the best unpublished/unreviewed paper. Both categories are a continuation from 2023. We received two entries in the published category, representing the University of Pretoria (UP) and the University of Venda (UV), along with six entries in the unpublished category from students at the University of Pretoria (UP) and the University of Stellenbosch (US). To ensure a fair and rigorous evaluation process, five judges have been appointed to review and assess the submissions.



Honours Project Competition

This year, the Honours Bursary Competition received fifteen entries from eight universities - North-West University (NWU), Stellenbosch University (SU), University of Cape Town (UCT), University of KwaZulu-Natal (UKZN), University of Limpopo (UL), University of Pretoria (UP), University of the Free State (UFS), and the University of the Witwatersrand (WITS). Submissions were made online via Google forms, with five group projects and ten individual projects entered. All fifteen projects were sent to five judges for thorough review and ranking.

We extend our sincere gratitude to the judges of both the Postgraduate Paper Competition and the Honours Project Competition for their generous contributions of time and expertise. The winners of these two competitions will be announced in the final SASA newsletter of 2024.

Honours and Third-year Bursary Competitions

The 2023/2024 bursary competitions were re-advertised in 2024 following a low response to the initial call for entries. The winners of these bursaries will be announced in the final newsletter of 2024.

Meanwhile, entries for the 2024/2025 bursary competition for second- and third-year students are currently open. Information about the competition was distributed to university representatives and Heads of Departments in October, and details are available on the SASA website. Additionally, announcements will be made in the upcoming SASA newsletter and across SASA's social media platforms.

A special word of thanks to SAS for the continued sponsorship of the Student Honours Bursary Competition and the Honours Project Competition.

International Statistics Literacy Project (ISLP) – Statistical Literacy Project Poster Competition 2024/2025

This year, the committee announced a South African-level competition, offering Honours and third-year students enrolled at South African universities the chance to participate in the 2024/2025 International Statistics Literacy Project (ISLP) Poster Competition. This initiative provides a unique opportunity for students to showcase their statistical skills and creativity on an international platform. The Poster Theme is free choice. The work should be based on the use, analysis, and interpretation of statistics (no statistical theory should be included in the poster).



A national jury will review all South African entries received (maximum of 3 entries from each institution), and choose the ISLP University winning poster for South Africa. This winning poster will then be entered as the South African entry for the ISLP 2024-2025 International Competition, where an international jury will consider all national winning entries from various countries, from which the very best ISLP posters from around the world will be chosen, and displayed at the 65th ISI World Statistics Congress, to be held in The Hague, Netherlands, in October 2025. Delia North serves as the country coordinator for this initiative. Information about the competition has continuously been communicated to university representatives, Heads of Departments, and through the SASA newsletter.

Registration for the competition is open from 1 July to 7 December 2024, and completed posters must be submitted electronically by 28 February 2025.

Capacity Building in Statistics Education

At the request of the SASA President, Inger Fabris-Rotelli, two projects were initiated in 2023 under the auspices of the Education Committee.

Curricula collation

Over the last few months, a task team led by Michael von Maltitz has been gathering comprehensive information on the content of Statistics degree programs offered across South Africa, covering both undergraduate and postgraduate levels. Most institutions have contributed by completing their modules on a data-gathering worksheet. The team plans to convene with participants at the SASA 2024 conference to finalize the data collection.

Following this, an Honours group from the 2025 cohort will be tasked with compiling and analysing the data, and do a detailed report on the findings. The task team aims to present well-informed recommendations by mid-2025.

High School Statistics Translation and videos

The initial phase of this project involved creating a core set of explanatory slides, complete with examples, that cover the curriculum in the areas of data handling/statistics and probability. This task is being led by a team composed of Amy Langston (Rhodes University), Farai Mlambo (University of the Witwatersrand) and Najmeh Nakhaei Rad (University of Pretoria). The team is to ensure that all slides are compiled in line with the current CAPS and IEB syllabus documentation. Once the English slides are finalized, they will be translated into South Africa's other



official languages, followed by the recording of short videos. This project remains ongoing.

In closing, I wish to express my heartfelt gratitude to each member of this committee for their unwavering positivity and dedication. Your commitment to advancing statistics education in South Africa, often at the expense of your own time, is truly admirable. Thank you for your selfless contributions and for continuously driving this important work forward.

The Young Statisticians' network aims to create awareness of statistics as a discipline and profession, both in industry and academia. Biweekly Newsletter campaign summary


A total of 16 campaigns were created and deployed from January to October 2024. This constituted of a 43% open rate and 8% unique click rate on the emails


The summary is provided in the table below. This table indicates the number of newsletters sent, the number of recipients per campaign, and the number of recipients who opened the campaigns.


SASA EVENTS

SASA INTEREST GROUP REPORTS

The year 2024 was a year of innovations and new initiatives. The year 2024 saw an increase in the number of Special Interest Groups (SIGs) to nine under the auspices of the South African Statistical Association (SASA) community of practice. The SASA-SIGs in 2024 include the Multivariate Data Analysis Group (MDAG), SASA Bayes, Extreme Value Theory (EVT), Spatial Statistics, Data Science, Forecasting, Biostatistics, Statistics Education, and Research Networks (StatSNetSA). From these nine SASA-SIGs, Data Science, Forecasting, StatSNetSA, and Statistics Education are among the newly introduced SIGs in the statistics community of practice. A lot of activities took place in all these SIGs in 2024, and these activities include seminars, workshops and PoT-Talks. Several international reputable guest speakers were invited to grace the events of the SIGs, and these guest speakers gave excellent and insightful presentations to their respective statistics special interest audiences. The attendance of the participants in most of the seminars and workshops organised by the SIGs in 2024 was very good. Aside from the SIGs, there were a lot of activities and initiatives from the various SASA Committees notably the Education Committee, Communications Committee and Sponsorship, among others. The year 2024 also witnessed major initiatives and collaborations with other associations, councils and organisation such as the South African Council for Natural Scientific Professions (SACNASP) and South African Mathematical Sciences (SAMS), among others. Overall, it was exciting to note the commitment of the members to the SASA community of practice development throughout the year, 2024. With this



commitment exhibited by the members throughout the year, it is clear that SASA is in good hands for future development and sustainability.

MULTIVARIATE DATA ANALYSIS GROUP (MDAG) COMMITTEE

The Multivariate Data Analysis Group (MDAG) was established in 2013 and has received growing support from SASA members throughout the years. MDAG remains an affiliated member society of the International Federation of Classification Societies (IFCS).

A new executive committee member is elected annually. Prof. Sugnet Lubbe (Stellenbosch) was re-elected as the Chairperson of the committee for the 2023-2027 term at the annual general meeting (AGM) on 28 November 2023. An additional member for the 2024-2028 term will be elected at the 2024 MDAG AGM.

We are aware of the following conferences that were attended by MDAG members in 2024: International Workshop on Compositional Data analysis (CoDaWork), International Federation of Classification Societies (IFCS) conference and the International Conference on Robust Statistics (ICORS) and Data Science, Statistics & Visualisation (DSSV).

The pre-conference MDAG workshop is presented by the Centre for Multi-Dimensional Data Visualisation (MuViSU) on "User-friendly biplots in R with biplotEZ". In this workshop, delegates will be introduced to the main aspects of biplot methodology and receive access to the newly developed functions of the biplotEZ R package with applications on real data in various contexts.

The DSSV conference will be hosted by MuViSU, the South African Statistical Association (SASA) and MDAG. This international conference will take place in the Kruger National Park, 7-9 July (https://iasc-isi.org/dssv2025/).

THE EXTREME VALUE THEORY INTEREST GROUP

The EVT special interest group (SIG) aims to introduce and nurture the study and knowledge of statistical theory and its application specifically in Extreme Value Theory (EVT) to the broader statistical community in South Africa. EVT is a branch of statistics that looks beyond normality to solve those problems in society that have a low frequency of occurring but can have severe or devastating local and global impacts.

EVT research allows for interesting interdisciplinary cross-over applications in all branches of statistics including time series analysis, Bayesian analysis, spatial statistics, artificial intelligence and biostatistics.

The EVT convening committee consists of the chair Prof Andréhette Verster (University of Free State), the vice chair Prof Daniel Maposa (University of Limpopo), and Dr Ansie Smit (University of Pretoria). During the course of the year, the committee organized three online seminars.

The first seminar was presented by Prof. Dr. Maud Thomas from Sorbonne Université Laboratoire de Probabilités, France on the 10th of April. Her research interests include statistics, extreme value theory and machine learning and its applications to actuarial sciences. The topic of her talk was "Generalized Pareto Regression Trees for Extreme Event Analysis with specific application to cyber risks".

The second seminar took place on the 4th of June in the form of a POT talk. A POT talk is defined as a speed talk session which gives young (and advanced) academics the opportunity to introduce themselves and their research to the EVT community – no matter the stage of progress. Each person receives 5-10 minutes with 2-3 summary slides to present the research problem/topic and progress that they've made or hoping to make. After the talk, a discussion session follows where the audience can give feedback and comments on the proposed work. The first presenter was Nicholas Kwaramba, a PhD student from the University of the Free State. The title of his talk was "Bayesian Application to Ramos Model". The second listed speaker was Thambeleni Portia Nevhungoni from SAMRC / UKZN who presented her PhD study titled "Childbearing Transition Dynamics among Women in Rural South Africa: A Multiprocess Modeling Approach".



The third seminar was presented by Nadine van der Walt on the 17th of September. Nadine is a Fellow of the Institute and Faculty of Actuaries (IFoA) of the UK and was the first South African to qualify through the IFoA via the research fellowship option. She was also UP's first PhD candidate in Actuarial Science. She is currently head of the technical development team Riskscape, which is a South African company that specializes in Spatial and Risk Products in the insurance and banking space. The topic of her talk was "Extreme Value Theory in Practice: Insights into Flood Risk Assessment".

In 2025 we will continue with our seminar series focussing on a combination of theoretical and practical applications of EVT.

We want to thank all the members for the high levels of interest and participation within this group and we are looking forward to 2025.

THE BIOSTATISTICS SPECIAL INTEREST GROUP

The Biostatistics SIG has held two events in a hybrid format this year. The first event was the "International symposium on current trends in modeling and software development in Data Science" from 20-23 February 2024. This event was hosted by the SAMRC Biostatistics Research Unit, jointly with the Data Science Institute at Hasselt University (Belgium), at the SAMRC Conference Center in Cape Town. The aim of the symposium was to provide a platform for discussion about both methodological and biostatistics capacity development topics and to initiate South-South and North-South interactions and engagement. This symposium was the opening event of The VLIR-UOS International Training Program project eR-BioStat ITP - Development of local E-learning platforms in (bio)statistics. During the first two days, Prof Ziv Shkedy (Hasselt University) showcased the eR-Biostat Platform for teaching and learning statistics at both the undergraduate and postgraduate level. In the second short course, Dr Rudradev Sengupta (Janssen Pharmaceutica) took participants through data analysis, modeling and reporting using R, R studio, and R markdown. The conference was held on 22 and 23



February and invited speakers from the North represented several institutions including Hasselt University, Jannsen Phamaceutica, The NIH and Brown University. There was also a high degree of geographic diversity with speakers and delegates from South Africa, Kenya, Mozambique, Botswana, Ghana and Ethiopia. Within South, speakers included leadership of Statistics departments from the University of Pretoria; University of Venda; University of Zululand; University of KwaZulu Natal; Stellenbosch University and University of South Africa; as well as the SAMRC and HSRC.

The second event was a guest lecture by Prof Lehana Thabane, who is the current Vice-President Research at St Joseph's Healthcare Hamilton in Canada. This lecture was held on 9 September 2024 at the SAMRC offices in Cape Town and covered the topic "Shifting the focus towards education and away from statistical significance: Revisiting the debate on whether it is time to get rid of statistical significance in pursuit of science.

StatsNetSA SPECIAL INTEREST GROUP

Statistics Supervision Network in South Africa (StatSNetSA) became a formal SASA Interest Group this year. The network has over 60 members, consisting of early- and mid-career academics in Statistics across South Africa. This interest group/network aims to support early-career doctoral supervisors in the Statistical Sciences, enhancing their effectiveness in guiding doctoral candidates to graduation, while also providing resources and support for the supervisor's own growth and promotion. It also seeks to create a more holistic and accessible experience for students, encouraging their transition into academia.

Over the past two years, online seminar series have been held to share experiences across the different tertiary institutions in South Africa pertaining to supervision, as



well as teaching and learning. This year, a range of seminar series has been offered, including one that highlights the experiences of senior supervisors within the Statistics community. Furthermore, a panel discussion on "Teaching in the current era of the Statistics discipline – how to deal with large classes and ensure critical thinking" took place in August, which covered topics on large classes, coding vs. real data vs. theory, postgraduate teaching, assessment practices, critical thinking. Following these, a seminar series aimed at highlighting emerging researchers in our Statistics community has commenced, where network members showcase their research and supervision experiences.

In addition to the seminar series, StatSNetSA has organized workshops to support the growth of academics in the field of Statistics. A Teaching Portfolio workshop took place in February and a workshop on NRF Grant Writing and Rating Applications will take place at the SASA conference this year.

The members of this network also have regular virtual meetings to discuss any challenges or successes they wish to share. This group now has an official LinkedIn page.

StatSNetSA is also busy with a research focus area proposal at NiTheCS. We hope that this will provide funding to the community through our group for further growth.

Main fund – day-to-day operations:

Income

- Membership fees have increased by 25% versus the budgeted amount, mainly due to the increasing adoption of group memberships.
- Interest income for the year remains high.

Expenses

- Executive expenses included an in-person meeting in January as the largest expense.
- All chapters' budgets were reallocated to the special interest groups, with very little take-up of the allocated budget.



- Our accounting and legal fees remain within budget.
- Bank fees are within budget.
- GlueUp subscription was renewed in March 2024.
- Auditor's remuneration had inflationary increases and remained within budget.
- The SASA EC will sponsor R16 000 for Conference, Bursaries & Scholarships, and Prizes each. This budget is expected to increase to R19 000 for Bursaries & Scholarships and R18 000 for Conference and Prizes from 2025.

Bursary and Scholarships:

A total of R16 000 was received from SASA for bursary and scholarships, with an additional R19 000 to be received and paid in 2025.

SAS provided an honours bursary of R35 000 that must still be spent. An amount of R50 000 was received to be paid out in 2025.

Prizes:

We received R16 000 from the SASA EC for the postgraduate paper competition. Additionally, we received R20 000 from SAS for the honours project competition, and R15 000 for the thought leader's prize.

In terms of funds spent, most of the funds remain in the fund, and will only be spent after the date of this report.
