# "The Intersection of Sustainability, Technology and Human Rights: Challenges and Solutions"

# Background

Raoul Wallenberg Institute's (RWI) in partnership with Business for Sustainable Development, Inc. (Philippines) will be organizing a program with a 3-day inception workshop and a main event where it will be showcasing solutions and designs to bring together an efficient way to address Business and Human Rights issues including Gender Equality and taking advantage of the available technology that we have. This will involve the participants from the 3-day workshop sessions who will be working together in clusters and they will present during the main event.


In this collaborative program, the first day inception workshop will be determining the vision and objectives of the event. Setting the goals and aligning the knowledge and understanding of the participants with the topic of Business and Human Rights and using Information Technology as the solution to concepts and designs. Workshop activity includes listing the issues and challenges predominant in each sector the participants belong to. The second day inception workshop will be presentations from best practices and effective solutions created by companies and organizations who have used Information Technology and Software Development to address BHR including Gender Equality issues. The workshop activity for this day will include choosing and prioritizing the issues identified during the first day. The last activity will bring together participants to develop ideas and designs to create a solution. Activities in the breakout rooms will include planning and the ideation process of developing a solution to the assigned BHR issue. During the 3rd inception workshop which will be the main event, participants from the workshop and invited guests from the private sector, government sector, civil society and other organizations will witness the final results of the inception workshop. There will be speaking segments for RWI to discuss the role of businesses in disclosing the right to a conducive environment for employees in the Philippines, this will tackle the challenges and opportunities. BSD will also be discussing the OECD Due Diligence Guidance for Responsible Business Conduct. Resource Speakers from UNDP and EU Delegates to the Philippines are also expected to be present.

The main purpose of this program is to encourage the effective dissemination and implementation of a healthy workplace through adapting human rights principles and abiding by due diligence procedures. Part of the promotion is to include opportunities for the audience to further their knowledge and skill set by attending training courses, workshop sessions and forming venues for businesses to foster partnerships and connections with like-minded individuals.
