





## Why a App?

- The more functions you want and need in your co-parenting app, the more expensive the app will be. That having been said, even the most expensive co-parenting app will cost you substantially less per year than a single one hour consultation with an attorney.
- If staying out of court and having effective communication with your co-parent is your goal, using any of these co-parenting apps will be better than trying to manage your co-parenting relationship the old-fashioned way.
- Goal is to **help co-parents avoid disputes**. But when disputes are unavoidable, it provides parents with an accurate and unalterable record of past conversations.
- The judge/ magistrate in your case orders you and your ex to use a specific parenting app. (Judges like parents to use coparenting apps because they've seen how much these apps can help reduce co-parenting problems – especially in <a href="high-reduce">high</a> conflict cases!)
- Minimize opportunities for conflict
- **Neutral communication** platform.
- Gateway for **parents to submit maintenance obligation** to the CPB Credit Bureau free




#### Where to begin...







- Download the Co-Parent app from the Google Play store
- Register your cell number as your user name
- Set your password
- Enter your co-parents cell number
- Follow the prompts to enter child details and shared arrangements
- Start your co-parenting journey with peace of mind








- Send secure instant messages via the app
- Get notifications when messages are received
- A complete record of your conversation is stored on the app's server
- The language filter helps ensure your messages are kept amicable
- Messages cannot be deleted once sent
- Request transcripts of conversations when required







