Topic: The New World (Dis)order: Economic & Political Challenges in a World of Heightened Global Risk


Topic Summary:

NOLANDS TAX:SHADES OF GREY

Speaker: Graeme Saggers

Bio: Graeme is a Chartered Accountant and Chartered Tax Advisor with over 15 years' experience. He holds a master's degree in Commerce, specialising in tax from UCT which was awarded with a distinction. As the Head of Tax at Nolands – Graeme has the overarching responsibility to educate colleagues and consult with Nolands clients on all relevant tax issues. He has presented and published research on various tax topics both locally and internationally, and he maintains a keen academic interest as a lecturer at the University of Cape Town.

Topic Summary: In February 2023, the Financial Action Task Force (FATF) added South Africa and Nigeria (along with some other countries) to the Grey List, a list that Mauritius was on from February 2020 to October 2021. Greylisting means that South Africa and Nigeria have been placed under enhanced monitoring of the measures they've put in place to counter the financing of serious crimes. In this session, Graeme Saggers will present on what the Grey List actually is, and why countries find themselves there. Sanjeeven Ramasawmy will then share some experiences on how greylisting affected operations in Mauritius and how they managed to get back in FATF's good books. Lastly, Graeme will reflect on what changes have already occurred in South Africa and Nigeria in response to the greylisting. He will also discuss what other countries can do to prevent themselves facing similar issues.
