## Overview

The Pennsylvania District Attorneys Institute is offering the Basic Prosecutors Course to district attorneys' offices throughout Pennsylvania. The purpose of this course is to prepare newly hired assistant district attorneys to make the transition from law student to prosecutor.

The course will be held June 3-6, 2024 at the [Sheraton Harrisburg Hershey Hotel](#) in Harrisburg, PA. The course will start at 8:30 a.m. on Monday, June 3 and end at approximately 1:00 p.m. on Thursday, June 6. The three and a half day course is in lecture, demonstration and practical exercise format.

The PDAI will provide a continental breakfast, lunch and a.m. and p.m. breaks Monday through Wednesday as well as a networking reception Monday evening. A grab and go breakfast will be provided Thursday morning. **Please submit a \$350.00 fee to PDAI to cover your food and beverage.**
