WELCOME & APOLOGIES 1. Tsitsi welcomed all to the meeting and confirmed that there was a quorum. All acknowledged that the AGM pack that was received. 2. MINUTES OF THE PREVIOUS MEETING The minutes of the previous meeting were accepted and approved by Tsitsi. **MOTIONS** 3. A. Acceptance of the updated Constitution Grammatical errors were amended and words such as National instead of Association as well as terms Chapter Executive changed to Chapter Leadership. No functional changes were made. Arthur proposed that the updated constitution be accepted and was seconded by Bruce. Members voted in favour of this motion. B. Acceptance of the policies and procedures document Only grammar and terminology were updated, no functional changes were made. Bruce proposed that the updated policies and procedures document be accepted and was seconded by Joni. Members voted in favour of this motion. C. Announcement of the new presidents handbook This is to assist chapter presidents in their role focusing on what they need to be doing as chapter president. Marie proposed that the new presidents handbook be accepted and was seconded by Frans. Members voted in favour of this motion. **CHAPTER PRESIDENTS' REPORTS** 4. Successfully set up curriculum for youth program and understanding the challenges that youth face joining the association. Digital Library project was established to share knowledge from other members to be used as resources. The Value Proposition was created to retain and grow membership. Tsitsi

6. ASSOCIATION TREASURER'S REPORT

- Melanie sent apologies, she submitted the report shared in the AGM pack.
- Membership has grown but not to pre-Covid numbers thus impacting the budget.
- GSF fees were lowered by 60% which benefits PSASA. These fees are for professional members only. This is why only professional members can vote on constitutional changes.
- Some errors were observed on the report. Amounts seem to be incorrect.
 - o Financial outlook: R122 should be R122 000 (Page 2)
- Profit and Loss: Increase in membership, only 1 new professional member. Associate members budgeted for was 110. Affiliate members have increased but budgeted for 16. Student membership decreased. Honorary members remain at 3.
- Fees have been revised for student memberships and lowered. Professional membership fees have increased and Associate and Affiliate fees will be revised.
- Expenditures have increased due to increase in fees of suppliers and services used by PSASA.
- Venue fees have increased and attendance at meetings have been low.
- More work is needed to recruit more members as this is where the bulk of the financing comes from.
- Tiffany proposed acceptance of the treasurer's report and Siphiwe seconded the motion. Members voted in favour of this motion.

7. MEMBERSHIP REPORT

- Tsitsi gave a brief summary of the membership report.
- 1 additional Professional member gained in March 2024 so now at 60.
- 83 Associate members, 13 new members added (under from what was budgeted for).
- 4 new Affiliate members gained, now a total of 8.
- Student member numbers have dropped, only had 1 and now there are none.
- Honorary members remains 3.
- 151 members in total this year.

8. **BUDGET 2024 – 2025**

- Tsitsi gave a brief overview of the budget.
- The following need to be amended:
 - Membership update: Amount should be R313 000 R420 000 not R313 - R420 (Page 1)
 - Expense management: Amounts R48 and R142 to be R48 000 and R142 000 (Page 1)

- More members are needed. Each member needs to assist with the growth of the association.
- Ian proposed acceptance of the budget 2024-2025 and Arthur seconded the motion. Members voted in favour of this motion.
