Minutes of the (hybrid) Annual General Meeting of the Netherlands-Thai Chamber of Commerce held on 22 April 2021 at The Okura Prestige and via Zoom webinar.

The AGM was attended by a total of 38 Ordinary Members (17 in person at the venue, 15 online and 6 via proxy). In accordance with Article 13 of the bylaws, a quorum of 20% of the ordinary members was achieved.

1. Opening

Mr. Rob Hurenkamp opened the AGM at 18.00 hrs. by thanking all members for joining tonight first hybrid AGM and their continuous support for the NTCC, despite the CV-19 situation.

2. Minutes of the AGM 2020

The minutes of the 2020 Annual General Meeting were approved without change.

3. Review of Activities Report 2020

The Executive Director presented a summary of the 2020 Annual Report to all attendants. A record number of online and offline activities were organized, including, activities for NTCC's several active groups and upcountry events to give NTCC members access to a broader network. NTCC membership stood at 259 paid members at year end.

The Executive Director thanked all the loyal sponsors and members for their support throughout the year.

4. Approval of Balance Sheet 2020 and discharge liability

5. Nomination of the auditor
