Started in 2018 already under the NTCC Sustainable Innovations Awards theme, we continue our "Road to Net-Positive" and wish to inspire fellow entrepreneurs accordingly.

Environmental

Does your company embrace the environment and does it show in your policies? How do you manage emission reductions and your carbon footprint? Does your company invest in environmentally sustainable initiatives and circularity?

Social

Do you create an inclusive working environment? Are you providing a fair pay and other employee benefits? Does your company engage with the (local) communities and people it affects?

Governance

Do you look critically at your own management performance? Are you following ethical business practices? How about your accounting integrity and transparency?

You first identify which category you wish to nominate your company for. Would you like to focus on Environmental achievement, you should go for the E category. If you wish to zoom into the Social work you do regarding your staff policies and local community engagement, the S category would be best. And if you have a strong focus on your corporate governance structure, you opt for the G category.

Please note that the above considerations are meant as broad guidelines to which you could envision various perspectives towards your ESG business practices. If you think your organization shows promises in any of these areas, we strongly encourage you to submit your application. Nominations are open to all NTCC corporate members - Multinationals, SMEs, foundations, and/or start-ups.




THE SELECTION PROCESS

- Sustainability & Entrepreneurship Center, Sasin School of Management

SELECTION CRITERIA

Apart from the specific ESG principles presented, the following criteria will also be examined by the jury to determine this year's winners:

-  Innovation
-  Collaboration
-  Overall Business Viability
