Double Occupancy (economy class ticket) 150,000.--THB/per person (net price)
Single Occupancy Supplement +20,000.--THB/per person (net price)

- **Upgrade for Business class:** GTCC calculates the business class supplement using the best available rate on the date of inquiry. The difference of economic and business class will be added directly to the standard package.
- If participants book their own flight, the package price will be reduced by 40,000. – THB.
- If the delegate already has valid travel insurance or a Schengen visa, the cost can be reduced upon request.
- Reserving a seat requires full payment.

Term & Conditions

The package includes:

- Round-Trip economy class airfare with taxes with the airline mentioned in the program.
- Loading Baggage with maximum weight of 25 kg.
- 6-night stay in 3-4 star hotels.
- All meals shown in the program
- Transportation and driver services according to the program.
- Standard tips for drivers and restaurants.
- Ticket for “MEDICA 2024”.
- Group leader service by GTCC representatives.
- Travel Insurance
- Schengen Visa application.
- 7% VAT (for GTCC’s services fee).

The package excludes:

- Personal expenses such as laundry, phone charges, minibars, etc.
- Cost for excess luggage weight from the airline’s quota.
- Renewing or extending passport validity.
- Additional expenses not mentioned above.

Cancellation Policy:

- Upon receipt of any form of written confirmation of participation by GTCC, a cancellation fee equivalent to 100% of the package price will be applied.

Remark:

- The program is subject to availability. The German-Thai Chamber of Commerce reserves the right to amend the program without prior notice. However, any changes will be made in the best interests of delegates.
- Air tickets and rooms are not reserved until the group reaches the minimum number of participants and are subject to availability on the group confirming date.
- The authorization for Schengen Visas is solely at the discretion of the German Embassy.
