Terms & conditions

FKCCI Agro Food Tech Expo 2020 will hereinafter be referred to as FAFE 2020 and participant, or in the alternative, party or parties, who book (s) display space in “FKCCI Agro Food Tech 2020” Exhibition, will hereinafter be referred to as Exhibitors.

1. FAFE 2020 will allot space / stalls to exhibitors on a first come first serve basis.
2. FAFE 2020 will allot space / stalls to exhibitors only on receipt of confirmation of space/stall booking in writing along with the full payment by NEFT / RTGS accompanied by the duly filled Application.
3. In the event of default of payment as aforesaid, FAFE 2020 reserves the right to cancel the booking, and the advance paid will stand forfeited.
4. All NEFT / RTGS to be made in favour of FKCCI Agro Food Tech Expo 2020.
5. FAFE 2020 reserves its right to change the floor plan and the location of the exhibitors space / stall. If possible exhibitors will be stationed as per his / her original booking or equivalent thereof.
6. FAFE 2020 will make appropriate security arrangements. However, FAFE 2020 shall not be liable for any loss and / or damage to Exhibitors equipment, display materials, samples etc. due to any reasons whatever. Adequately insurance coverage on the above items should be taken by the exhibitors from the country of origin.
7. FAFE 2020 reserves the right to re-posses or re-allot space / stall which is not occupied prior to and at the time of inauguration.
8. The schedule of space / stall possession shall be given to the exhibitor at the time of confirmation and the exhibitors shall be strictly adhere to it.
9. Exhibitors shall not assign this contract or a part thereof without prior written consent FAFE 2020.
10. Exhibitors will care for the flooring, walls and all other structures during space / stall decoration and also while bringing and removing materials on these matters fallow such instructions FAFE 2020 provides from time to time this is the essence of the contract.
11. Exhibitors shall ensure that no hazards or inflammable materials are kept in space/stall and shall also ensure to adopt adequate safety measures in this regard.
12. Exhibitors shall make good to FAFE 2020 all costs, damages and expenses resulting from fire, or any damages caused to the structure, etc. due to exhibitors negligence.
13. Exhibitors shall ensure that all demonstrations, interviews advertising, promotion and sales and marketing activities are conducted within space / stall. Aisles must always be kept clear for the visitors.
14. Audio/Visual display may be conducted within the space / stall at low volumes.
15. FAFE 2020 does not accept any responsibility for any misquotations, omissions or other errors that may occur in the compilation of any publication related to the exhibition.
16. A) In the event of the cancellations of space / stall, booking payments made towards the same will be forfeited.
B) Reduction in booked space/stall area booked and payment made towards the same will be forfeited;
17. Exhibitors (s) must ensure that the interior decoration of the space / stall is completed before the inauguration as per the time indicated in the schedule which will be given to the exhibitor upon confirmation of the participation.
18. Exhibitor (s) shall ensure that the space / stall is vacated as per the time indicated in the schedule, which will be given to the exhibitor upon confirmation of participation. FAFE 2020 will not in any way be responsible and /or liable for the general security after the close of the exhibition on the last day.
19. Every Exhibitor (s) shall ensure that his space is open to view and is staffed by competent representatives during exhibition hours.
20. If the Exhibitor (s) commits any breach of this contract and fails to remedy it promptly on receiving written notice from FAFE 2020 then FAFE 2020 may, by written notice, terminate this contract. Upon termination under this clause or otherwise, Exhibitor will forthwith vacate possession of the same. Exercise of rights under this clause will prejudice any rights or remedies of FAFE 2020.
21. FAFE 2020 will not be liable for any delays or failure in performance of any of its obligations under or arising out of the contract if the delay or the failure results from any of the following: Force majeure, acts of God, fire, flood, Earthquake, storm, explosion, accidents, riots, strikes, lockouts, Bandh /closures, war, civil unrest, industrial disputes, embargoes of any state of the emergency, or any other Govt. Act, law, statute ordinance whatsoever which renders it impossible or impractical for FAFE 2020 and Exhibitor (s) to perform and all previous negotiation, commitments, agreements between parties pertaining to this transaction stands cancelled.
