1.	<p><u>Welcome Remarks by Chairman Vinod Kesava and Wei Mei</u> Chairman Vinod Kesava (VK) welcomed all members to the first meeting of Carbon working Group for the year.</p> <p>Vice Chairman Wei Mei (WM) also welcomed all members and did a short presentation on the update of the carbon prices and the possible reasons for the decline in prices in recent months.</p>	
2.	<p><u>New Member Introduction by 3 DOM (Singapore) Pte Ltd</u></p> <p>Denise Ho briefly introduced 3 DOM and their interest and involvement in the circular economy, in making batteries and trading carbon credits. Denise shared their plans to establish themselves more in Singapore.</p>	
3.	<p><u>Update by Secretariat, Kavita Gandhi, Executive Director, SEAS</u></p> <p>Kavita (KG) introduced and updated the Working Group (WG) on SEAS activities. KG also shared the proposed working plan and activities for the WG in 2022.</p>	
4.	<p><u>SEAS member introduction and discussion of workplan 2022</u></p> <p>Chairman led the discussion on 5 of the activities in the WG workplan, and WG members also introduced themselves and shared what their interest were in the WG.</p> <p>1. <u>Carbon Roundtable</u> Through the mentimeter poll, WG shared that they would like to see other industry associations mainly in the Transportation, LTA, Fleet (e.g taxis, logistics), NEA and Data Centre industries to organise roundtables with. SEAS Secretariat to approach members to help to invite these associations for a roundtable.</p> <p>The outcomes that WG members would like to see in the roundtable are mainly clear guidelines and regulations, training, standardization, business matching and policies.</p> <p>2. <u>Development of Guidelines for carbon offsets</u> Companies have challenge articulating what their problems are in the sustainability and climate action route. The idea is not to develop own guidelines, but compile guidelines that are already available into a document for companies to refer to navigate their thinking. Kavita suggested breaking into groups to start the skeleton of the document before gathering inputs from the rest.</p>	<p>See Annex 1 for Mentimeter result</p> <p>SEAS secretariat to break WG into small groups for the document.</p>

	<p>3. <u>Advocacy & Engagement</u></p> <p>Through the mentimeter poll, WG members are interested to engage with policy makers mainly EMA, LTA, NEA and ESG. Members expressed interest in EMA as they found some overlaps in carbon emission and trading with EMA. Some of the questions members would like to address with the policy makers are the fuel policies, green mark certification, disconnect between policy and execution and incentivisation issues.</p> <p>Chairman Wei Mei suggest to come up with a wishlist of items we would like to discuss with government agencies before we invite them.</p> <p>4. <u>Carbon track in Asia Clean Energy Summit</u></p> <p>Through the mentimeter poll, WG members shared that they would like to see Policy, Decarbonisation and Carbon Markets areas in the Carbon Track at ACES 2022.</p> <p>5. <u>Other activities</u></p> <p>Members shared that they would like to see other activities like site visits, sharing of case studies and workshops.</p>	<p>WG members to email Secretariat items they would like to discuss with the agencies.</p>

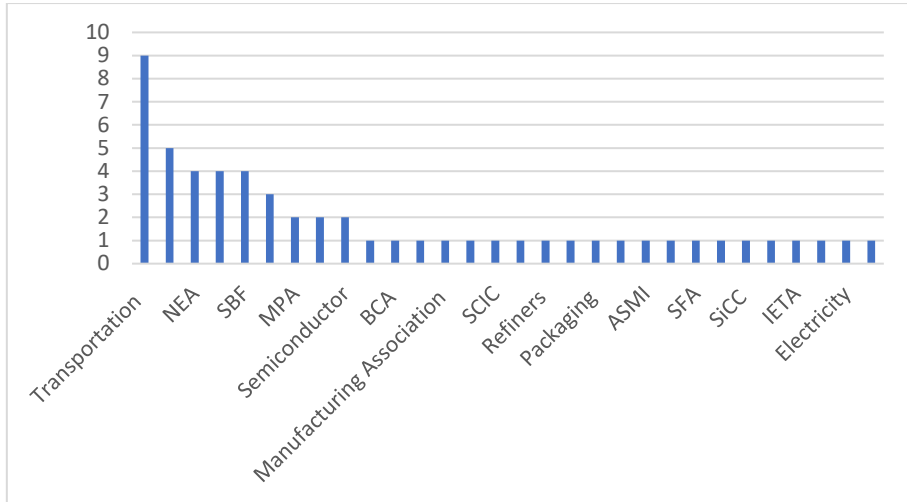

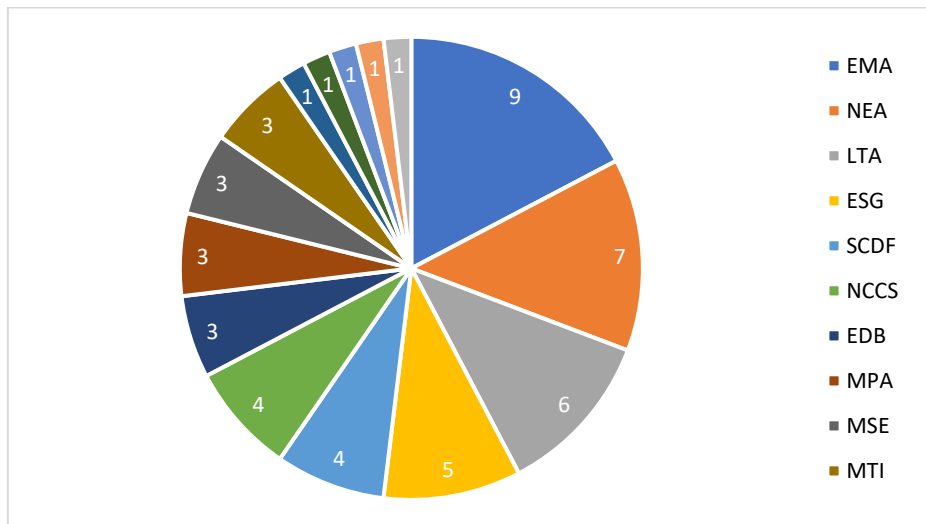

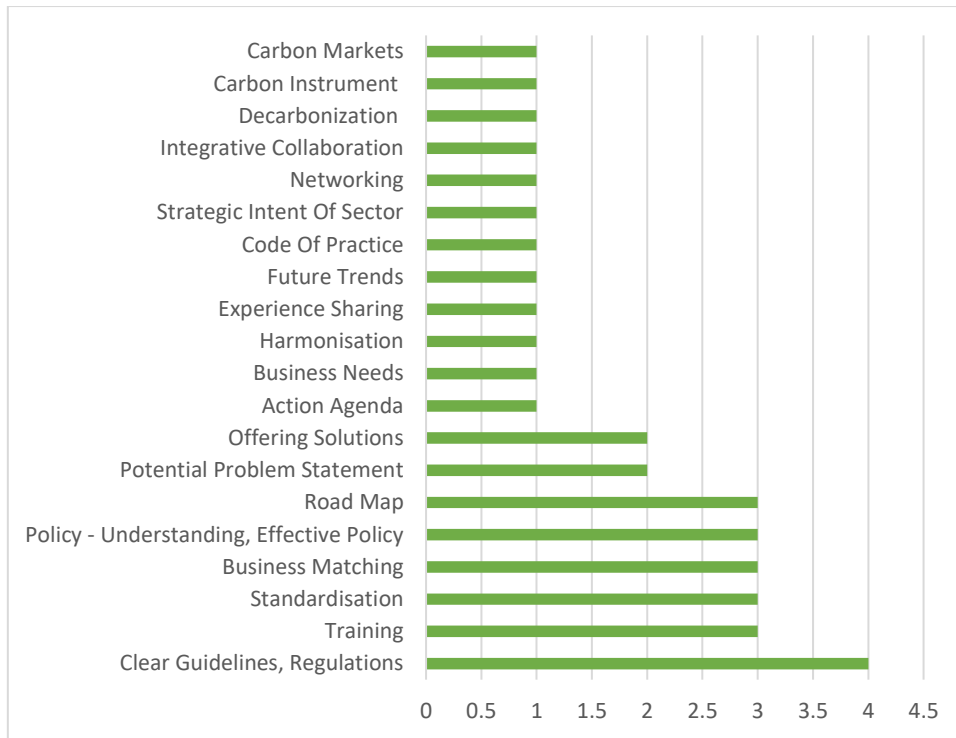
1) What other industry associations do you think we should organise roundtables with?



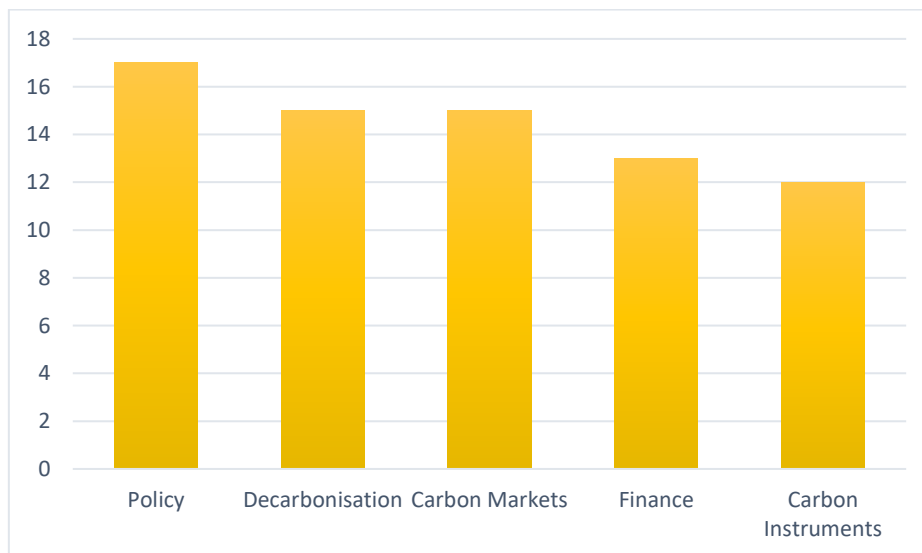
2) Which policy makers are you most interested to engage with?
