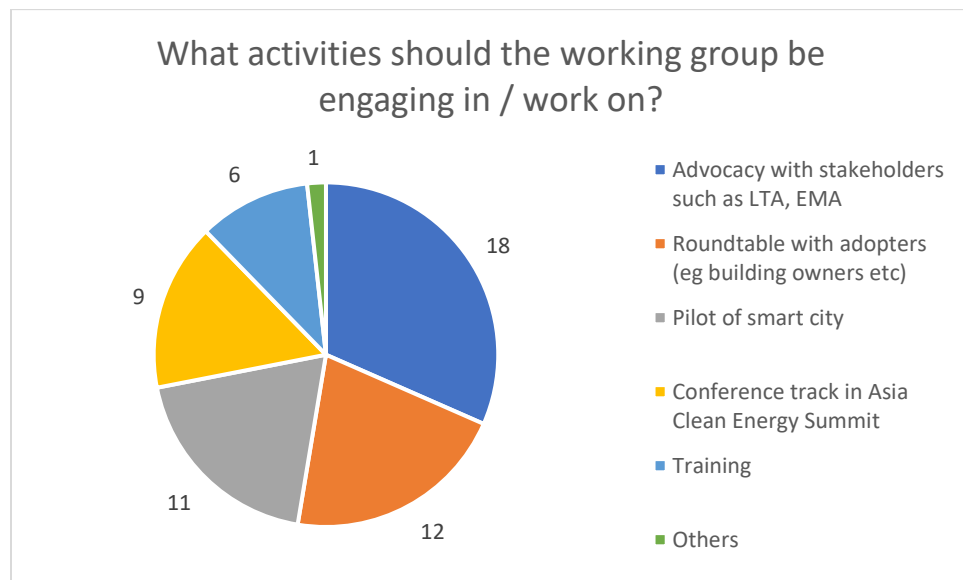
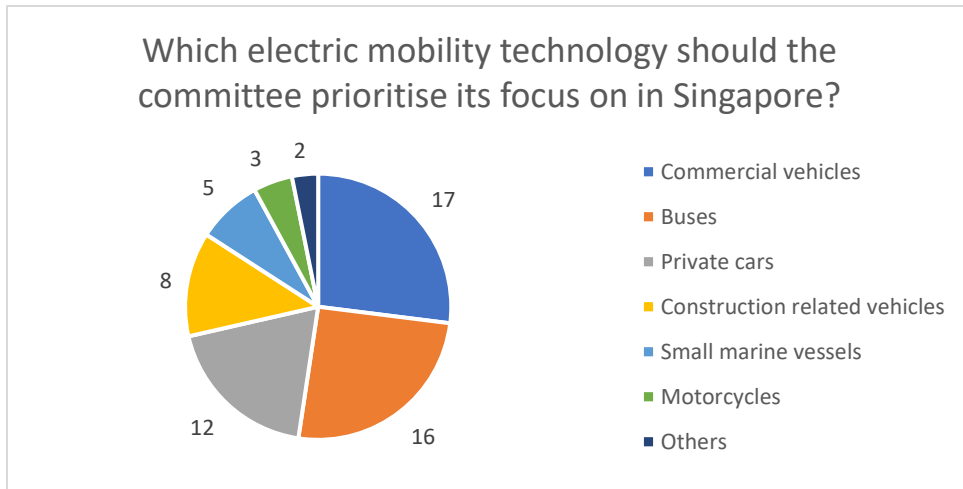

1	<p><u>Welcome and introduction by Chairman, as well as members introducing themselves.</u></p> <p>Electric Mobility Working Group Chairman, Dr Sanjay Kuttan, welcomed everyone to the meeting and invited everyone to introduce themselves around the room.</p>	
2	<p><u>Presentation by Mr Vins Low, Business Development Manager of Yinson Green Technologies Pte Ltd</u></p> <p>Mr Vins Low shared on Yinson Green's mobility services, chargeEV, the largest CPO in Malaysia and Moovita, providing leasing of a range of EV fleets (cars, trucks, bikes, etc.) embedded with telematics, connected through smart EV app to track data and driving behavior and ability to track carbon emission. After the presentation, Mr Low welcomed questions from the floor.</p>	
3	<p><u>Updates by Secretariat, Ms Kavita Gandhi, Executive Director, SEAS</u></p> <p>Ms Kavita Gandhi shared on the upcoming activities that SEAS is planning, including the business mission to Dubai, Asia Clean Energy Summit and PowerACE competition.</p>	

4	<p><u>Survey response from previous Electric Mobility survey</u></p> <p>Chairman shared on the survey responses that was conducted after the first meeting. The survey was to understand what the members would like to pursue in this working group.</p> <p>1. Focus sector on electric mobility committee (Refer to Annex 1)</p> <p>On which electric mobility technology should the committee prioritise its focus on in Singapore, most of the members answered commercial vehicles and buses. Members could also form groups by themselves to focus on other sectors should they wish to under the subcommittee of Electric Mobility WG if they garner enough interests.</p> <p>2. Advocacy with agencies and other associations (refer to Annex 1)</p> <p>Question on what activities should the working group be engaging in, 18 people responded to engage in advocacy with stakeholders such as LTA or EMA. Chairman suggested for members to deepdive on what they would like to bring up to LTA or other agencies (e.g the gaps of the EV ecosystem in Singapore). One suggested topic with LTA would be to discuss the recent EV charging bill that LTA has released (refer to Annex 2).</p> <p>Another possible engagement that we can explore is to collaborate with other associations like Singapore Shipping Association, Maritime and Port Authority of Singapore, etc where there are aligned agenda/ problems that both associations are facing which we can collaborate on.</p> <p>3. Training in the Electric Mobility industry</p> <p>As most Singapore companies are reliant on overseas technologies, there are often miscommunication and gaps on implementing and operating the charging technologies in Singapore. Hence, members suggest to have workshops for overseas technology companies to teach on how to adopt and convert their solutions in Singapore. Such as 1-day programme on energy tech in EV or working with ESS group to develop these programmes.</p>	<p>Secretariat to share survey for members to take.
